

**LIMITED WARRANTIES**  
**BY**  
**KEDROS FURNITURE**  
**(“Manufacturer”)**

These warranties and the conditions apply to the sale of the Manufacturer’s products. In order to make a claim to the Manufacturer for any defective products a purchaser must make a claim within the time periods and in the ways stated in these Warranties. These are the ONLY warranties made respecting the products otherwise, including, but without limitation, the implied warranties of merchant ability and fitness for a particular purpose not expressly set out in this warranty.

**Cedar Patio Furniture**

The products will be free from defects due to faulty materials or workmanship including missing parts and parts damaged due to shipping, cracking, or warping for a period of ninety - (90) - days from the date of sale.

**Children’s Furniture (Ages 2-10)/ Custom Millwork Products**

The Products will be free from defects due to faulty materials or workmanship, including finishes of all laminated product for a period of one (1) full year from the date of sale.

**\*\*Please Note: Kedros Furniture will “Not Guarantee” or offer a “Warranty” for products that come directly in contact with water and or other liquid substances.\*\***

**Upholstery Services**

Upholstery work will be free of defects due to faulty materials or workmanship for a period of ninety (90) days from the date of the delivery of the work.

**Warranty Conditions**

Warranty coverage takes effect at the date the buyer receives delivery of the product or the upholstered product.

In order to establish a valid warranty claim the buyer must notify the Manufacturer in writing within 30 days of discovery of an alleged defect and within the warranty period. Warranty claims will be deemed to be waived unless filed within the time stipulated.

Proof of Purchase (sales receipt) is required for warranty coverage. The Manufacturer reserves the right to refuse a warranty claim if the buyer fails to present proof of purchase. Upon receipt of warranty claims and proofs of purchase, the Manufacturer will inspect the product or upholstery and/or investigate any warranty claims.

If the Manufacturer finds product or upholstery to be defective, its liability is limited to repair or replace the defective product or upholstery free of charge F.O.B. Kedros Furniture, Edmonton, Alberta. The Manufacturer is not responsible for any transportation cost incurred by the buyer.

Warranty coverage is provided to the original buyer, and is not transferable without the written permission of the Manufacturer.

This warranty covers normal usage of the products and services and is void if the buyer damages, abuses, misuses, or modifies the product or upholstery, fails to maintain the product or upholstery as is reasonable or necessary, or, with the exception of normal maintenance, has the product or upholstery repaired by anyone other than the Manufacturer or a representative authorized by the Manufacturer. In this regard the Manufacturer recommends that the cedar products be re-stained at least once a year and that the cedar products should not be over-exposed to harsh weather elements.

The Cedar Seating Products have a maximum load capacity of 300lbs and the Manufacturer is not liable for any claims resulting from loading in excess of the weight.

There are no other warranties or agreements relating to the product or materials, whether express, implied, by statute, or otherwise, including without limitation, the implied warranties of merchantability and fitness for a particular purpose.

Repair or replacement of defective product or upholstery is the only remedy provided by the Manufacturer and it will not be liable whether in warranty, contract, tort, including negligence, or otherwise, for any further loss, damages, expenses arising directly or indirectly from the sale or use of its product or upholstery.

Acceptance by the buyer of the products or upholstery constitutes the buyer’s acceptance and approval of the terms and conditions of the warranty.
